5. Rights of data subjects

- II. obtain the indication: a) of the origin of the personal data; b) the purposes and methods of processing; c) the logic applied in the case of processing carried out with the aid of electronic instruments; d) of the identification detail concerning the data controller, of the managers and any representative designated pursuant to Art. 3.1, Reg. 679/2016; e) the subjects or categories of subjects to whom the personal data may be communicated or who can learn about them as appointed representative in the State, managers or appointees;
- III. obtain: a) updating, rectification or integration of data; b) the deletion, transformation into anonymous format or blocking of data processed in violation of the law, including data which does not need to be kept for the purposes for which they were collected or subsequently processed; c) the attestation that the operations referred to the letters a) and b) have been brought to the attention, even for their content, of those to whom the data have been communicated or disseminated, except in the case where such fulfillment proves impossible or involves the use of means manifestly out of proportion to the protected right;
